1. With a disability or a long-term sickness	Certificate of decision MDPH (Maison Départementale des Personnes Handicapées) or certificate of long-term illness or disability card.
2. Living in a municipality in France classified as « <i>Zones de revitalisation rurale (ZRR)</i> » : Rural Revitalisation Zone French public areas « Zonage de politiques publiques » L'Observatoire des Territoires (observatoire-des-territoires.gouv.fr) (only available in French)	Proof of residence (energy bill, water bill, home insurance, etc.). If the participant's name does not appear on the certificate of residence, a certificate of honour with the name/signature of the host or an administrative certificate from the sending institution must be completed.

4. French higher education grant holder on social criteria grades 6 and 7	Notification of national (French) grant award
5. French school education grant holder (« <i>college</i> ») (grades 1 to 3) ➤ <i>Not applicable to higher education students</i>	Notification of national (French) grant award
6. French school education grant holder (<i>lycée</i>) (grades 4 to 6) ➤ <i>Not applicable to higher education students</i>	Notification of national (French) grant award
7. Belonging to a « <i>foyer</i> (French taxable household) with a « <i>Quotient familial CAF</i> (family quotient in the <i>Caisse d'allocation familiale</i> – CAF) » that is less or equal to 551 €	CAF family allowance certificate
8. Jobseeker for more than one year – category A ➤ <i>Not applicable to higher education students</i>	Pôle Emploi certificate
9. Enrolled in one of the French following systems: ○ schemes to prevent early school leaving; ○ « <i>Contrat de Volontariat pour l'insertion</i> » ○ « <i>Parcours contractualisé d'accompagnement vers l'emploi et l'autonomie (Pacea)</i> » and « <i>Garantie jeunes</i> » ; ○ « <i>Service militaire adapté (SMA)</i> » or « <i>Service militaire (SMV)</i> » ○ TAPAJ programme (alternative work paid by the day).	Certificate of enrolment in the home institution or photocopy of the <i>contrat de volontariat</i> (voluntary service contract) <u>or</u> certificate of integration into the relevant system, etc.
